#### 4 FIRST-AID MEASURES

- **General Information:**  
Take off contaminated clothes. Wash immediately with plenty of water. Continue rinsing for at least 10 minutes. If any symptom persists, seek medical attention.

- **Hands:** Chemicals resistant gloves butyl-rubber protective gloves.
- **Skin protection:** Wear appropriate protective clothing. Avoid skin contact with the spilled product.
- **General protective and hygienic measures:** Keep away from foodstuffs, beverages and feed. Immediately remove all soiled and contaminated clothing. Wash hands before breaks and at the end of work. Avoid contact with the eyes and skin.
